 - 6: The applicant hereby charges in favour of Pro-Design all the applicant's rights, title and interest in and to any land (including land acquired in the future) to secure the payment of all monies and the observance and performance of the applicant's obligations pursuant to this agreement and hereby authorises Pro-Design to register a caveat over the applicant's land pursuant to the charge
